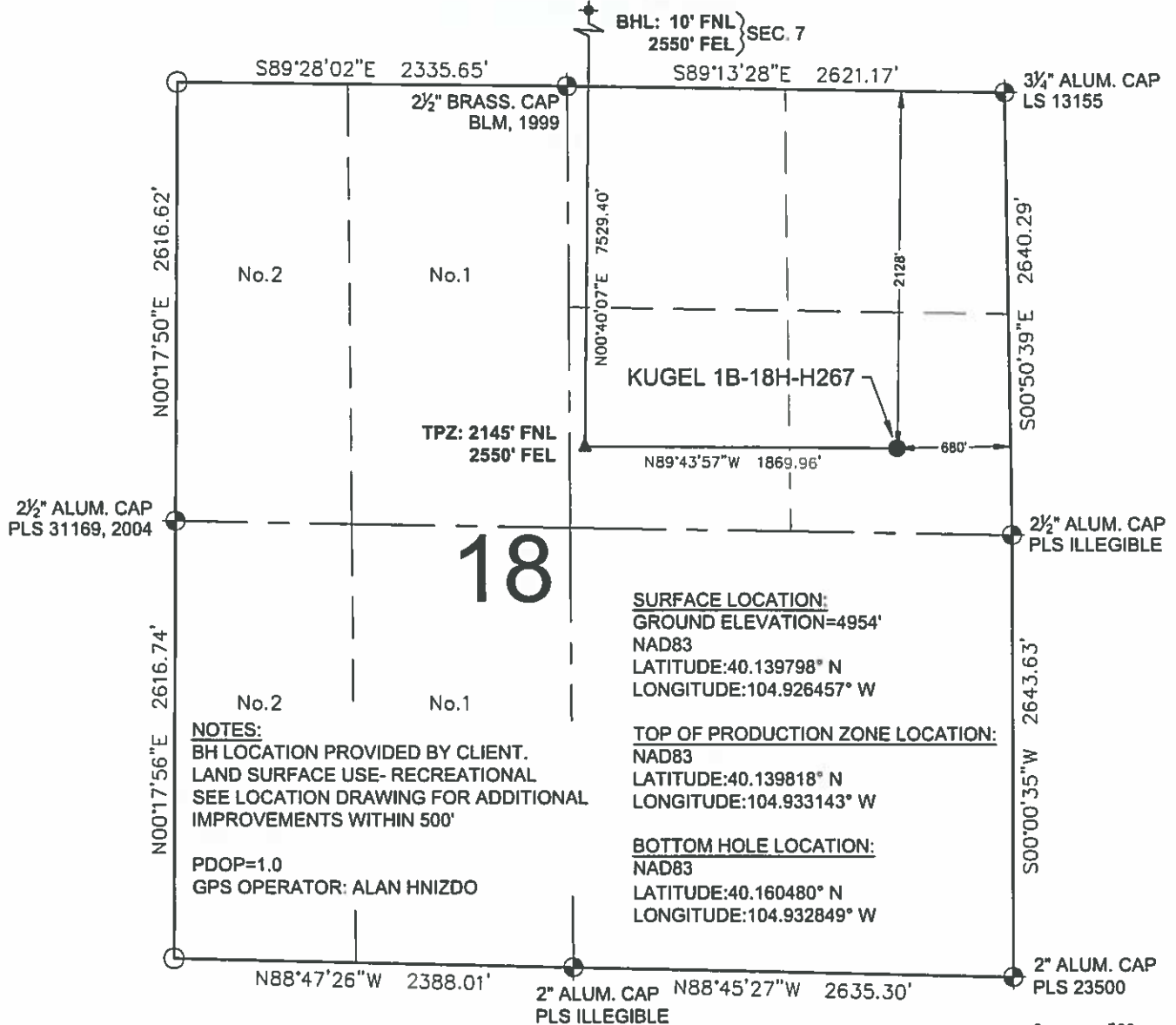


KUGEL 1B-18H-H267 WELL LOCATION EXHIBIT

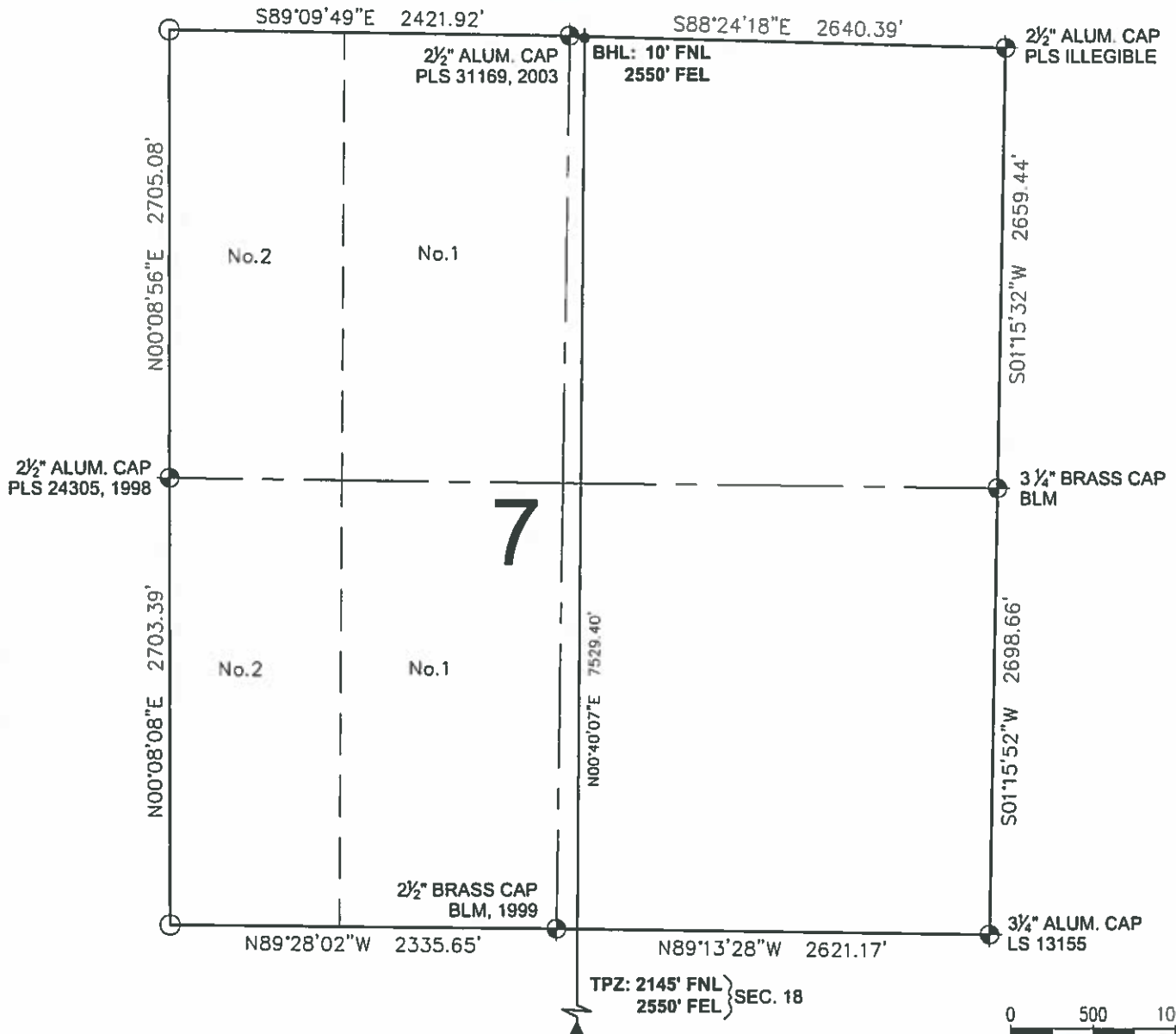
