#### COMMENTS:

Pioneer is requesting continued temporarily abandoned status on the Lonesome 22-10R well as it is not feasible to rework the well at this time due to current market conditions. A Form 4 for temporarily abandoned status was submitted to the COGCC on 10/2/2017. A Mechanical Integrity Test dated 6/30/2015 was previously submitted. The well is closed to the atmosphere via the wellhead secured and shut in at the surface as well as a cement retainer at 1,450'. The next operator will determine the future utilization of this well.
