Pioneer is requesting continued temporarily abandoned status on the Lorencito 10-18-34-66 well as it is not feasible to rework the well at this time due to current market conditions. A Form 4 for temporarily abandoned status was submitted to the COGCC on 10/2/2017. A Mechanical Integrity Test dated 4/7/2015 was previously submitted. The well is closed to the atmosphere via a wellhead secured and shut in by a valve as well as a bridge plug set at 1,680'. The next operator will determine the future utilization of this well.
