Afternoon Rick,

Per our conversation and your recommendation at 11:45 today, this e-mail is being sent to update the COGCC on the status of moving forward with the monitoring well installation at the Sitzman 1 U location, located on the property owned by Mr. Davenport.

PDC attorney, Mr. Andrew Fiske and the attorney for Mr. Davenport, Mr. Ryan Cordsen with the law firm of Grant & Hoffman have been communicating, however to date PDC has not received approval to install the wells / access the property. On August 2<sup>nd</sup> PDC sent it first written request to install the monitoring wells, subsequent requests/calls have been placed and until recently there has been a general lack of responsiveness. The wells are required to continue with the investigation activities identified in the approved supplemental Form 27 document number 401738130. Without the landowners approval by EOB today September 28, 2018 the timeline to meet the COAs in the supplemental Form 27 of October 19, 2018 *cannot be* met.

Thus, the intent of this note is to document in advance of the deadline the rationale for not moving forward with the investigation actions proposed and approved by the COGCC.
