Comment:

Stable, perennial plant community is well established & contouring in project area is continuous with surrounding Landscape. Intermediate wheatgrass, Fourwing saltbush, June grass, alfalfa, Sagebrush & Galleta grass were desirable species identified. One area approximately 20 ft. x 40 ft. in center of location is infested with Cheat grass, though the rest of site is uniformly revegetated. There is an Approved Variance for leaving access road unreclaimed. Final Reclamation is being left "In Process" until CA in Stormwater section is resolved.
