Caerus respectfully requests relief of a Condition of Approval from document number 400394003. Specifically, Caerus requests relief of the COA for netting over the ponds at the Hunter Mesa Water Treatment Facility. The COA on page 6 states: "The multi-well pit must be fenced and netted. The operator must maintain the fencing and netting until the pit is closed." Caerus has security fencing around the facility along with mesh fencing to keep small animals outside of the pond area. There are no nets in place over the ponds since all water stored has been through DAF treatment, which removes free-phase hydrocarbons and solids from the produced water. In addition, there are floating covers in place on two of the ponds. The DOW approval (3/22/13) on the same document states "The BMPs included in the Form 2A application adequately address wildlife concerns. Approved: Jim Komatinsky 3-22-2013"
