#### COMMENTS:

Request to flare is being made as a result of Anadarko shutting down their Third Creek System which was the gas sales outlet for the Champlin 459 Amoco 2. It is estimated that 12 MCFD will be flared in a onsite combustor. No hydrogen sulfide is present in the gas. All gas produced from the Painted Pegasus Petroleum operated wells on this lease is sold and allocated back from a single meter at the Champlin 459 Amoco Lease. A gas analysis from this meter is attached.

**Operator Comments:**

This flaring request is made necessary by the shutting down of the Anadarko Third Creek Gathering System. The Champlin 459 Amoco 2 was making over 4 BOPD and approximately 12 MCFD when the shut in took place. Oil Revenue dominates the economics of this lease. At this stage of the shut in no timely alternatives appear viable to reestablish beneficial gas deposition and the length of this request to flare is unknown at this time.

-The flaring units being purchased and installed will be equal to the standard Cimarron Equipment 98+ enclosed combustors.

- At this point we have no idea if or when the wells will be reconnected to a pipeline. Obviously the most desired outcome would be the reopening of the Third Creek System by Anadarko, a third party or a producer consortium. Lacking clarity of what is likely to happen, any date would be nothing but a guess. If Third Creek is not reopened, the dates for reconnecting to pipeline will be different for each lease but will almost certainly be over a year if at all.

- Painted Pegasus Petroleum initially explored unsuccessfully if there were any easy ways to monetize the flared gas. Most options considered were expensive and uneconomic, difficult, requiring long regulatory approval and long construction lead times. At this stage of the shut in, committing to this level of evaluation is not practical especially in light of not knowing the future pipeline options. These types of creative gas uses will first likely be considered and employed at other more prolific Painted Pegasus Petroleum leases which are not able to be flared.

- Any flaring will be compliant to all CDPHE requirements. An environmental consultant has been deployed to assist in securing all necessary permits.
