I have reviewed the Form 2A Oil & Gas Location Assessment and have the following comment.

The Facilities section lists quite a few tanks, separators, VOC Combustors, Vapor Recovery Towers, etc. However, the Location Drawing does not show nearly that many production facilities. Are the count of production facilities in the Facilities section correct? Since this location is not in a Buffer Zone, Bison isn't required to show each individual production facility. If the Facility count is correct, and to avoid any confusion between the Location Drawing and the Facilities section, please revise the Location Drawing to either show all of the listed production facilities or just indicate the general area of the disturbed area where the production facilities will be placed.
