Operator shall submit a Supplemental eForm 27 to assess direction of flow, groundwater gradient, and water quality at the subject location. This assessment will require the installation of additional monitoring wells upgradient and downgradient of the subject pit, pursuant to Rule 908.b.(9).B.ii, Rule 909.a, Rule 909.b.(2), and Rule 910.b.(4).

Although there was not a corrective action date to comply with the COA, the additional monitoring wells would be installed within the 4th quarter of calendar year 2018.

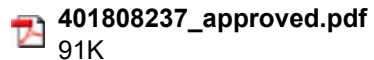
