Noble Energy respectfully request continued TA status. The well is closed to the atmosphere via a RBP bridge plug set at 6895' on 8/31/2016 for an off-set frac, specifically for PDC's Connie 26E-202. Noble will return the well to production once a rig is available - unknown time frame as we are currently working through a large back log of P&A work for offset mitigation work for DJ basin activity. Noble will run an MIT if the well is still TA'd after two years. The Operations summary was submitted with the Form 5A, Doc # 401136260. The successful MIT was performed on 7/2/2018 and was submitted on doc # 401694727.
