

MEMORANDUM OF SURFACE USE AGREEMENT

This Memorandum of Surface Use Agreement ("Memorandum") is made this 19th day of October, 2018, by Guttersen Ranches, LLC and Guttersen and Company LLC (collectively, "Surface Owner"), P.O. Box 33709, Greeley, Colorado 80633 and Noble Energy, Inc. ("Noble"), 1625 Broadway, Suite 2200, Denver, CO 80202.

Surface Owner and Noble entered into a Surface Use Agreement dated October 19, 2018 (the "Surface Use Agreement") providing for the use of all or portions of the surface of the land described below by Noble in connection with certain oil and gas operations and the compensation to Surface Owner (as provided in the Surface Use Agreement) for use of the surface of the land associated with the drilling, testing, completion, recompletion, reworking, reentry, pumping, operation and maintenance of the wellsites to be located in Weld County, Colorado on the following described lands:






This Memorandum is executed by Surface Owner and Noble for the purpose of placing all persons on notice of the Surface Use Agreement, including the below referenced waiver language contained in the Surface Use Agreement. This Memorandum will be provided to necessary agencies for permitting purposes. The Surface Owner expressly grants consent to Noble to locate any number of well pads, production facilities and wells. Nothing contained in this Memorandum shall be deemed to amend or alter any terms of the Surface Use Agreement.

Guttersen shall fully support Noble's efforts to permit such wells, including granting consent to locate any well greater than fifty feet (50') from wells that exist as of the date hereof pursuant to COGCC Rule 318A.(c) and granting consent to locate any well outside of the GWA windows as defined in COGCC Rule 318A.(a). Guttersen shall grant any necessary property line waivers required under COGCC Rule 603 as well as any other waivers under any applicable new or modified regulations of COGCC or other Governmental Authority with jurisdiction over Noble Operations. Noble may provide a copy of a memorandum of this Agreement to the COGCC as evidence of this waiver.

This Memorandum of Surface Use Agreement ("Memorandum") is made this 19th day of October, 2018, by Gutttersen Ranches, LLC and Gutttersen and Company LLC (collectively, "Surface Owner"), P.O. Box 33709, Greeley, Colorado 80633 and Noble Energy, Inc. ("Noble"), 1625 Broadway, Suite 2200, Denver, CO 80202.

Surface Owner and Noble entered into a Surface Use Agreement dated October 19, 2018 (the "Surface Use Agreement") providing for the use of all or portions of the surface of the land described below by Noble in connection with certain oil and gas operations and the compensation to Surface Owner (as provided in the Surface Use Agreement) for use of the surface of the land associated with the drilling, testing, completion, recompletion, reworking, reentry, pumping, operation and maintenance of the wellsites to be located in Weld County, Colorado on the following described lands:

This Memorandum is executed by Surface Owner and Noble for the purpose of placing all persons on notice of the Surface Use Agreement, including the below referenced waiver language contained in the Surface Use Agreement. This Memorandum will be provided to necessary agencies for permitting purposes. The Surface Owner expressly grants consent to Noble to locate any number of well pads, production facilities and wells. Nothing contained in this Memorandum shall be deemed to amend or alter any terms of the Surface Use Agreement.

Gutttersen shall fully support Noble's efforts to permit such wells, including granting consent to locate any well greater than fifty feet (50') from wells that exist as of the date hereof pursuant to COGCC Rule 318A.(c) and granting consent to locate any well outside of the GWA windows as defined in COGCC Rule 318A.(a). Gutttersen shall grant any necessary property line waivers required under COGCC Rule 603 as well as any other waivers under any applicable new or modified regulations of COGCC or other Governmental Authority with jurisdiction over Noble Operations. Noble may provide a copy of a memorandum of this Agreement to the COGCC as evidence of this waiver.

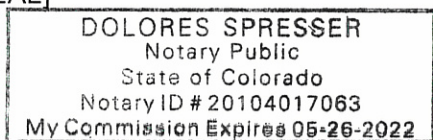

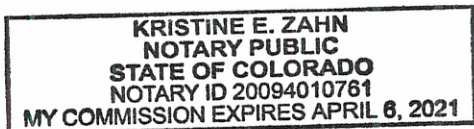

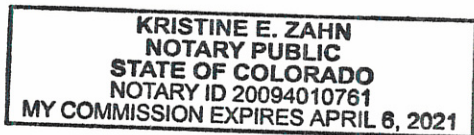
