Operator Comment: Stained soil around the wellhead and on the side of the pumping unit was removed and remediated. Stained soil was a result of recent well work. Cleanup work started Monday July 23rd and finished Saturday July 28th. Wellhead was washed down and clean gravel placed in areas where the stained soil had been removed. In the future, mitigation efforts will include using oil absorbent pads during well work operations.
