Operator Comment: End of March 2019, a third party vendor will truck in 262 cyd of compost to this site. The area in question is 2 acres of which the farmer/owner will have disked the field smooth. The third party vendor will spread the compost evenly across the two acres using a tandem axle spreader truck. The compost will then be ripped and disked. The farmer/owner will be able to plant his desired crop. Additional FIRR will be completed once above stated is done.
