Basis for Review: Corrective action dates are not attainable

Operator Comment: As noted in the Inspection Report the weed populations that survived Laramie's efforts toward weed control are late in the lifecycle. Some effort will be made toward removal of weeds but the complete extent of weed control and reseeding will not be fully resolved until after the Spring growth period in 2019. Request modified deadline for CA #1 to be June 1, 2019.

The second CA, CA#2 should be addressed as a separate line item. Issues related to Stormwater will be resolved prior to the 9/17/2018 deadline.

COGCC Decision: **Not Approved**

COGCC Representative: CA Date for Weed Control stands at 9/17/18. It is understood that the weed control will be ongoing & continued in Spring of 2019. Discussion with Operator showed that they had misunderstood the CA, thinking that all weed control should be complete by 9/17/18.
