#### COMMENTS:

TEP Rocky Mountain LLC (TEP) is requesting permission to repair a well with a leaking collar. During the initial pressure test in preparation for completion, the SG 423-26 well pressured up to 9,200 psi and then began to bleed down and lost pressure. The bradenhead pressure is currently 0 psi. The pressure test and CBL are attached for reference.

If permitted, TEP proposes the following repair and completion plan:

1. Run 40 arm caliper log
2. Set Owen X-Span Internal casing patch at identified leak
3. Frac well as per designed
4. Set 2 drillable Bridge Plugs below Casing Patch and fish patch
5. Remediate casing collar leak with cement squeeze
6. Drill out cement and frac plugs and begin producing well.
