The first agreed upon action item in your original email is "*Noble will email Doug Andrews true acreage numbers for interim reclamation for the pads listed above.*"

None of the interim reclamation acreages have been reduced. The three well only pads that will be 0.8 acres after interim reclamation are not what I'm referring to. Its the three pads that have production facilities on them including the temporary water recycling facility that we were expecting Noble Energy to interim reclaim back more. I do not see interim reclamation addressed in your email of November 18 and it is our understanding that these could be pulled in more. Please advise.
