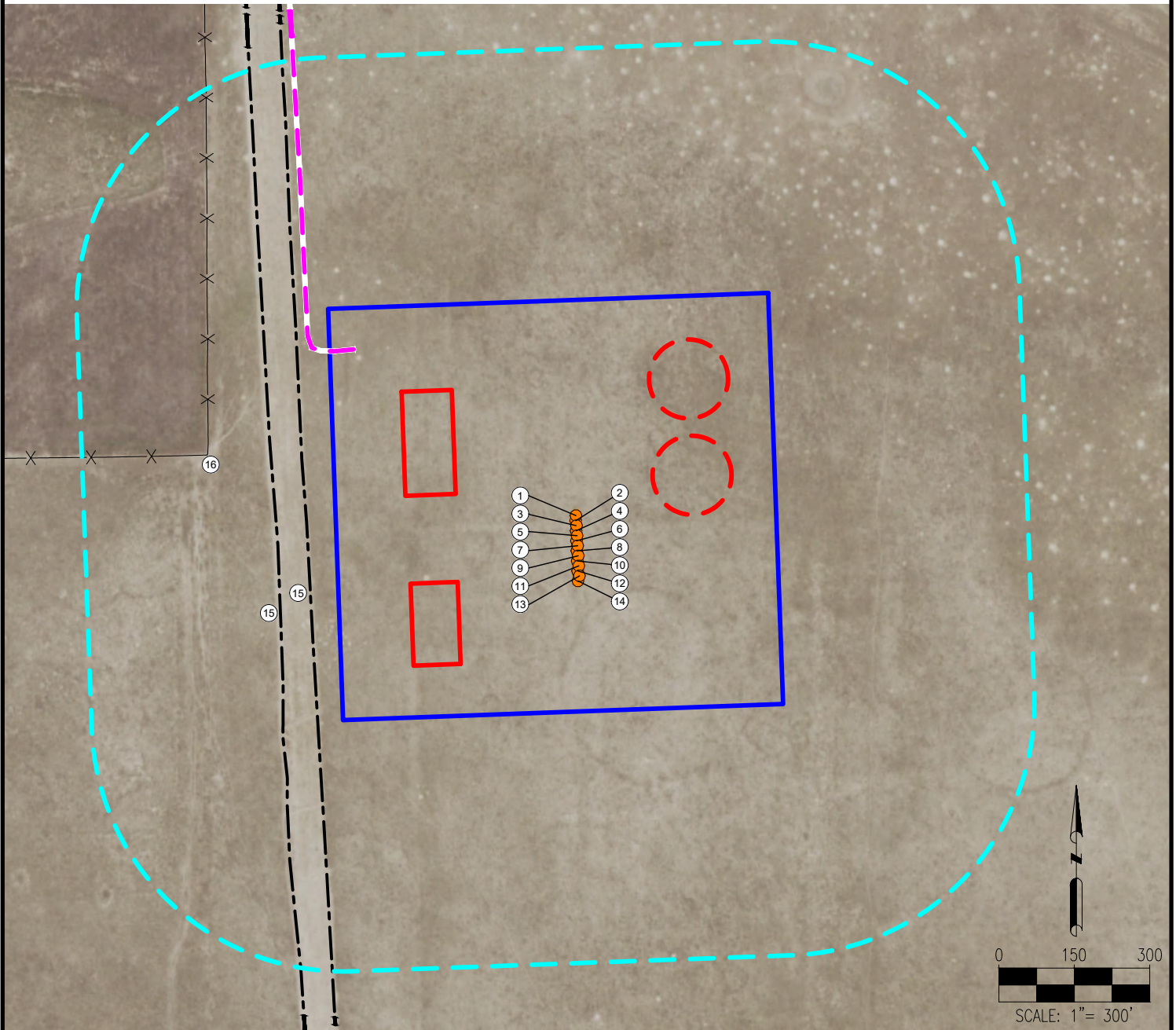


CANVASBACK PAD LOCATION DRAWING
