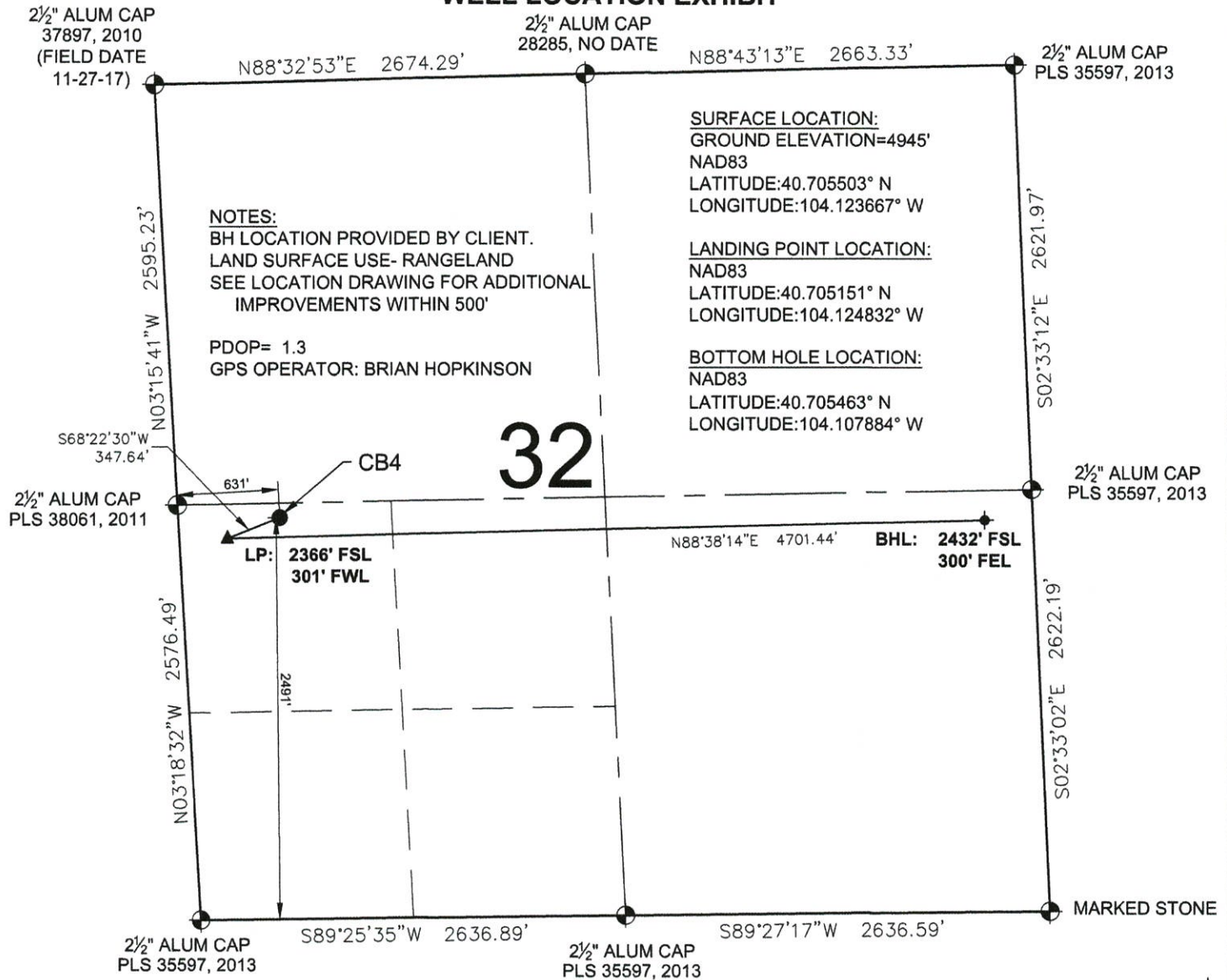


CB4 WELL LOCATION EXHIBIT
