TEP Rocky Mountain LLC requests permission to repair the PA 23-24 per the following procedure. Wellbore diagrams are attached:

1. Run 40 arm caliper log
2. Set 30' Owen X-Span Internal casing patch to cover collar at 1,584'
3. nipple up frac stack and psi test to 7,200 psi for 30 mins
4. Frac well as per designed
5. Run tubing to 1,629' prep to pump balance plug
6. Pump 25 sks 15.8 PPG Class G Cement balance plug to 1,629'
7. Squeeze cement to max psi of 2,500 psi
8. Shut well in for 24 hrs
9. Drill out 330' of cement
10. Psi test casing to 500 psi for 15 mins
11. Drill out all frac plugs
12. Turn well over to flowback
