The size of this pit was 2 feet, 8 inches wide x 2 feet 8 inches long and 3 feet deep. Since that date this pit has been covered and is no longer in use. The location is and has been used as native grass pasture and for grazing cattle. Visual inspection indicates that all reclamation of the location has been completed and no further remediation is necessary. Please see attached pictures. Despite multiple requests we have not been able to obtain an executed surface use agreement from the surface owner. </div>
