Corrective Action: Odor observed by COGCC staff related to referenced oil and gas location, actions must be taken to stop the odor per Rule 805.b. Additionally, this matter has been referred to the CDPHE for possible further investigation.

Operator Comment: Extraction immediately employed additional odor BMP's when notified of the inspector's allegations. This included doubling the odor suppressant additive and adding a cooler to the mud cycle process on the same day as the inspection.

Extraction is submitting the FIRR as notification that the corrective action has been completed. However, as part

of this notification, Extraction would like it noted that it has employed the recommended amount of odor suppressant as a BMP to the drilling mud from the beginning of the drilling phase. The state inspectors have been out to the Rinn Locations approximately 18 times prior to this inspection and had made no note of odors coming location, demonstrating that Extraction has been following industry, and COGCC recommended practices.

Extraction would also like it on record that the inspector did not follow any state approved practices or methods for Scentometry in the issuance of its corrective action, and therefore, cannot demonstrate non-compliance with 805.b and more specifically 805.b.(1)A., which references CDPHE Regulation No. 2 Odor Emission, 5 C.C.R. 1001-4, Regulation No. 3 (5 C.C.R. 1001-5), and Regulation No. 7 Section XVII.B.1 (a-c) and Section XII.
