Desirable vegetation establishment is not uniform across site and areas are infested with annual weeds (i.e. Curly Dock, Kochia, Pig Weed, cocklebur) in what appears to be former positions of equipment. Native Sunflower &amp; Aster are also growing on location, which while not weeds, are not commensurate with the reference area vegetation (Hay field). Soils at entrance area appear to remain compacted Access road diverting from Nichols Gravel Pit Road has not been reclaimed. Refer to Photo Log attached.</p>
