Operator Comment: Smith oil is currently conducting pit closure activities. A Form 27 (Doc # 401827890) was submitted on November 6, 2018 proposing the pit closure sampling plan which was approved by COGCC on November 14, 2018. On November 27, 2018 pit investigation activities were conducted. A supplemental Form 27 (COGCC Doc # 401827890) reporting the results was submitted on December 13, 2018. Upon approval of the supplemental Form 27, Smith Oil will conduct reclamation at the location per COGCC Rule 1004.

Additionally, on November 27, 2018 the remedial items under COGCC remediation project # 7403 were

addressed (removal of residual stained soil, non-e&p stained soil removal [stockpiled onsite pending waste profiling/pit closure activities], and former wellhead release soil sampling). This information was submitted in a supplemental Form 27 (COGCC Doc # 401870740) on December 13, 2018. The non-e&p stained soil will be hauled offsite for final disposal during pit closure activities.

The additional samples for comparative agronomic analysis will be collected on 12/19/2018. Results will be reported via a Form 4 sundry notice along with a detailed reclamation plan which will include landowner input.
