COMMENTS:

This form is being submitted to document that an in-situ remediation system had been installed on the I30 595 well pad (335588) in support of remediation project (TBD) associated with the closure of pit facility (TBD).

After removal of the pit liner, field observations and a series of discrete grab samples were collected to determine if soil impacts were present. After identification of soil impacts, a Form 19 was submitted to document below-liner impacts. The pit was backfilled, and a soil auger drilling rig was used to identify vertical and lateral extent of soil impacts, and install soil vapor extraction (SVE) wells. These wells are now on a monthly operations and maintenance (O&M) schedule with regular data reviews. When data indicates that an endpoint in the remediation has been achieved, a soil auger rig will be scheduled to collect clearance samples for laboratory analysis. Upon receipt of laboratory results demonstrating completion of the remediation project, a Notification of Completion will be submitted to the COGCC to document project completion and request for closure.

Attached is a status report prepared by the environmental contractor responsible for the remediation system installation and collecting O&M readings.
