Comment: **Inspection #682503847 documented that the location/facility no longer appears to be active, and required final reclamation activities to be conducted. Unable to find evidence that final reclamation has been conducted in accordance with 1004 rules; Oil and gas facilities/equipment/trash debris remains on location. Abandoned risers have not been removed, access road remains. Compaction alleviation and revegetation activities have not been conducted. Original corrective action and date remains applicable.**

Corrective Action:	Perform final reclamation in accordance with COGCC rule 1004.a; remove all equipment, risers, trash debris and remaining facilities on location and establish vegetation with total perennial, non-invasive uniform plant cover of at least eighty (80) percent of pre-disturbance or reference area levels. Use a seed mixture requested by the surface owner, or a mixture prescribed by the local county NRCS. Ensure erosion controls are implemented to stabilize the seeded soil, and continue to monitor and manage this site until Final Reclamation has passed. Revegetation activities shall be completed no later than 12/17/2018.	Date	12/17/2018
