	<p>This location is not in compliance with Rule 1004. Reclamation rules require reclamation activities to be conducted within twelve months of plugging on non-cropland which should have been 6/6/17. Well was plugged 6/6/2016. The removal of all equipment has not been performed nor does it appear any reclamation work has been performed on the well location, facility or access road; weedy, annual vegetation was observed which includes but not limited to cheatgrass, field bindweed, and kochia. Gravel remains along the access road, facility and well location which has not been re-contoured or re-graded and decompacted to meet the adjacent terrain. Please refer to the attached inspection photos for more detail.</p>	
Corrective Action:	<p>Perform reclamation in accordance to COGCC 1004 reclamation rules and requirements. Reclaim access road and location. Establish vegetation with total perennial, non-invasive uniform plant cover of at least eighty (80) percent of reference area levels. Ensure erosion controls are implemented to stabilize the seeded soil. Remove gravel along access road and location and perform compaction alleviation, re- contour/re-grade. Operator shall continue to monitor and manage this site until the location meets Rule 1004 standards. Final reclamation activities shall be complete no later than 5/1/2019 or sooner depending on favorable environmental conditions.</p>	Date 07/06/2017
