Comment:

This location does not meet reclamation regulations. Access road travels partially within crop and non-cropland. Ruts remain evident. Unable to find evidence that compaction alleviation, recontouring/regrading and revegetation activities have been conducted on access road. Crop vegetation does not appear to be successfully establishing on the well location. Compaction concerns likely remain. Additionally, powerlines (4 poles parallel to the access road) leading north to the well from the RUDNIK #33-27 location have been left, and appear to be interfering with agricultural activities. This is surface equipment associated with the abandoned oil and gas location and requires removal.

Perform reclamation in accordance with COGCC 1000 series rules including, but not limited to, removal of surface equipment, compaction alleviation, recontouring, and regrading, on access road and location. Additionally, establish vegetation with total perennial, non-invasive uniform plant cover of at least eighty (80) percent of pre-disturbance or reference area levels on access road within non cropland. Use a seed mixture requested by the surface owner, or a mixture prescribed by the local county NRCS. Ensure erosion controls are implemented to stabilize the seeded soil, and continue to monitor and manage this site until Final Reclamation has passed. Collaborate with the surface owner to determine mitigating measures that will allow reclamation work to be conducted in such a manner as to not interfere with agricultural activities, or crop production. Reclamation activities shall be completed no later than 3/15/2019
