**General Comment:**

This is an Abandoned Location Inspection for Wells API#045-07799 & 045-07800; APDs first Approved 4/27/2001 for Ballard Petroleum; Permits Abandoned 6/15/2002 by Encana; though Change of Operator Form10 was not in Files and these two Wells remain with ACE Oil as Operator of Record. This is also a Follow Up to Insp Doc#680101498 dated 2/2/17 in which it was noted that Form 4s Abandoning permits were Blank; this appears to have been resolved & Forms now have entered data.

It does not appear that these AL Wells were drilled on Location with Two Producing Wells; therefore these are Well Releases on an Active Location.
