General Comment:

Location shows as Built in 2009 aerials, and Not Built in 2006 (there is a two-year gap in aerial images). No wells were drilled or equipment installed on site; though excavated Pit area is visible in 2009 aerials. APDs for Eight Wells were filed in 2006; Seven permits were Abandoned in 2018, leaving One XX Well, API#045-13268 Permit expiring 4/4/20 on Location. 2A was refilled in 2018, Approved with Expiration Date of 4/4/21. Surface Disturbance does appear to be at Eight acres as detailed in 2A. Steep Fill Slopes are rocky, with little to no vegetation. Approximately a dozen Concrete Jersey barriers are stored at West edge of Pad. Snow cover prevented a detailed assessment of pad Surface or access road conditions.

As Location was constructed and has not been Drilled or Reclaimed for ten years Operator will be required to go through the Notice to Operators: Interim Reclamation Procedures for Delayed Operations (January 5,2017). Refer to Reclamation Section.
