Wexpro Comapny has used reasonable good fait efforts to identify surface water sources within 1/2 mile of the proposed project area. There is a small stock pond approvimately 0.5 miles southeast of the site and one that is approximately 1.75 miles southwest of the proposed facility. Both ponds are depicted as intermittent on the USGS topographical map. Field observation was conducted on September 6, 2018 and confirmed. See photos attached. Based on the findings, there are no water sources within 1/2 mile and Wexpro Company will not be conducting surface water monitoring as per the requirements as setforth in Rule 908.b.(10).
