	<p>Inspection doc. #663900944 dated 4/19/2012 documented that location has been re-seeded.</p> <p>This location does not meet reclamation regulations; insufficient vegetative cover. Prior re-seeding activities conducted does not appear to have been sufficient. Location predominantly bare and exposed soil or composed of undesirable weedy plant species such as kochia. Stormwater erosion degradation evident on location, and to the south of location. See attached photos. Additional reclamation work required.</p>	
Corrective Action:	<p>Repair erosion degradation and install BMPs. Perform reclamation in accordance with COGCC 1000 series rules and establish vegetation with total perennial, non-invasive uniform plant cover of at least eighty (80) percent of pre-disturbance or reference area levels. Use a seed mixture requested by the surface owner, or a mixture prescribed by the local county NRCS. Ensure erosion controls are implemented to stabilize the seeded soil, and continue to monitor and manage this site until Final Reclamation has passed. Revegetation activities shall be completed no later than 3/31/2019.</p>	Date 03/31/2019
