Purpose: Shut In Temporarily Abandoned Reminder: _____

Comment: Wellhead was leaking per landowner and upon inspection it was noted as leaking through a stuffing box component. Operator brought in a temporary flare on 1/3/2019 in accordance with best management practices per COGCC Engineering to burn wellhead gas prior to working on wellhead. Pressure went from 600 psi to 10 psi during flaring per operator and flare was removed on 1/5/2019. On 1/4/2019 operator replaced stuffing box wellhead components and brought in water truck to lower well pressure to 0. On 1/7/2019 inspector rechecked the well for leaks at the wellhead and found none.
