The recycling will support development areas DP207 and DP209 in the Denver-Julesburg (DJ) Basin. This plan is submitted in accordance with the Colorado Oil and Gas Conservation Commission (COGCC) Rule 907.a.(3). Noble will treat E&P waste generated from their operations and use the treated water in the development of DP207 and DP209. These mobile treatment systems will not accept wastes from third parties.
