Establish vegetation with total perennial, non-invasive uniform plant cover of at least eighty (80) percent of reference area levels. Ensure erosion controls are implemented to stabilize the seeded soil. Remove the remaining equipment; perform compaction alleviation, re-contour/re-grade access road. Manage noxious weeds by 6/14/2018 due to that flowers will develop shortly. Operator shall continue to monitor and manage this site until the location meets Rule 1004 standards. Final reclamation activities shall be complete no later than 9/17/2018 or sooner depending on favorable seeding conditions.
