Comment:

Previous inspections documented that location does not meet reclamation requirements; concrete base, gravel remains, insufficient vegetative coverage. Inspections required operator to remove base/gravel and conduct reclamation/revegetation activities.

Concrete base appears to have been removed, however, location remains predominantly bare and exposed soil or dominated by undesirable weedy plant species. Unable to find evidence that revegetation activities were conducted; location is not progressing towards COGCC 1000 series standards. Original corrective action and date remains applicable.

Corrective Action:

Perform reclamation in accordance to COGCC 1000 series reclamation rules and requirements and establish vegetation with total perennial, non-invasive uniform plant cover of at least eighty (80) percent of predisturbance or reference area levels. Use a seed mixture that matches the adjacent pastureland or a seed mixture requested by the landowner. Ensure erosion controls are implemented to stabilize the seeded soil, and continue to monitor and manage this site until Final Reclamation has passed.
