COPUC Gas Gathering Pipeline ruptured. Released has been stopped. Surface contamination is approximately 200' x 400'. We are removing contaminated dirt from on top of the line to investigate the cause. Booms are in place in areas of snow melt/run off, and in Parachute Creek. We are building berms and dikes to stop the run off from entering creek. Working to remove contaminated soil from the surface. We are taking water samples from Parachute Creek for analysis.
