**General Comment:**

COGCC joint inspection with EPS S. Arauza and Western Integrity Inspector R. Murray. Follow-up to eForm 19 Spill/Release Report (doc #401905874, Spill/Release ID #460722).

Met with B. Middleton, B. Rollins, and R. Koeneke of Caerus Piceance LLC to discuss spill/release of produced water from Basin Pipeline WC-4 Vault including initial response efforts, delineation of impacts, and remediation options. Operator's representatives guided COGCC inspectors along the ~1,400' length of the flow path, which extends from the point of release (POR) located north of the Orchard Compressor Station to a gravel pit (part of the Una Pit Complex) located south of Caerus' Tipping OD 34 pad (Location ID #334094). See photos.

On inspection date, operator was advised to provide additional spill notification to CDPHE for impacts to surface water (gravel pit) and to the Local Governmental Designee as well as to submit an eForm 19 Spill/Release Report. Operator provided CDPHE and LGD notification while submitting the eForm 19 Spill/Release Report (doc #401905874) on the same day. Additional spill documentation is provided under Spill/Release ID #460722.
