**General Comment:**

COGCC Environmental Inspection to determine the status of pit facility ID 118127. Inspection of pit area only; no nearby battery/production facilities or wells inspected.

Pit location was determined based on aerial imagery. COGCC personnel found no surface indication of a pit present in the location. The pit status has been changed to closed. However, no associated remediation or site investigation has been conducted. Should future conditions at the site indicate contaminant concentrations in soils exceeding COGCC standards or if ground water is found to be impacted, then further investigation and/or remediation activities may be required.
