There is an area (photo 2) where erosion caused additional disturbance out into the pasture. This area needs to be recontoured to grade and reclaimed/reseeded. See attached photos

Reclaim and stabilize the area (COGCC photo 2) where erosion caused additional disturbance out into the pasture. Closely monitor the interseeded area and reseed as needed. Location remains out of compliance.

Comment: The culverts along the access road have not been installed to good engineering practice (photo 5-10). The rock rip/rap is improperly installed as it is piled too high in front of the culverts which appears to be restricting water flow. The wattles placed around the culverts are temporary BMP's and are not a long term solution. A long term solution could be properly installed sediment traps and rock check dams. Additional BMP's are required up slope (e.g. check dams) near the double gates shown in photo 3.

Corrective Action: Install or repair required BMPs per Rule 1002.f. Location remains out of compliance.
