Details of Plan of Work: (State names of and expected depths to objective sands: Show sizes, weights, and lengths of proposed casings; indicate mudding jobs, cementing points, and all other important proposed work.)

On Oct. 31, 1952 7" OD 20 & 23# casing was run and cemented at a depth of 5100' KB with 170 sacks reg cement with 2% gel. The hole was drilled to a total depth of 5140'. A description of the casing run is as follows: 7" OD 23# (27jts) 838', 7" OD 20# (137jts) 4311' J-55 ST&C casing Scratchers were placed 5096'-5040' and 4970'-4937'. Centralizers were placed 5096', 5040', 4970' 4935'. The cement was allowed to set 48 hours after drilling out cement the casing was tested with 500 psi for 30 minutes finding no leaks. Work was continued.
