

We propose to drill a well on the above described well using rotary tools. Approximately 170' of 10-3/4" OD 32.75# H-40 casing will be set as surface casing and cemented by an approved method. A 9" hole will then be drilled through the Dakota formation. An electric log will then be run to total depth. If any formation is found to be commercially proeuctive 7" od 20 & 23# casing will be run and cemented by an approved method. The casing will then be perforated and the well prepared for producing.
