FINANCIAL ASSURANCE COAs:

- Financial Assurance of \$1,578,000.00 has been provided (Surety ID: 20180162). The COGCC'S third party is reviewing this closure estimate. If there is a shortfall, the Operator shall provide the additional amount of the shortfall within 60-days of notification of the shortfall.
- Financial assurance, based on re-evaluated cost of reclamation, closure and abandonment estimate, will be reviewed at five (5) year intervals over the life of the Facility; however, the COGCC reserves the right to review the financial assurance for adequacy on a more frequent basis.

GENERAL SITE COAs:

- The Operator shall familiarize and provide any additional training to the local fire authorities (Brighton, Mountain View, Fort Lupton, etc.) that may respond to an incident at the Facility.
- Within 45-days of the Form 28 approval, submit to the COGCC Engineering Integrity Group a GIS map with information, (shape files) in a suitable format showing the location of flowlines, type of pipe used in each segment, monitor points, valve locations, booster pump locations (if any) from Extraction's well sites that will transport fluids to and from the Badger Central Gathering Facility. Provide and update as part of the annual report.
- Within 45-days of the construction of the facility, the Operator shall demonstrate compliance with Rule 604.c.2.G (requirement for 150% containment in a buffer zone). This shall be reviewed, stamped and signed by a Colorado Professional Engineer (P.E.).
- Baseline sampling of water wells and monitoring wells shall be sampled prior to startup of the Facility. At a minimum, water sampling shall be analyzed for the constituents provided in Rule 609.e.
- The Form 28 expires at the time the Form 2A (Document Number 401606721) expires.
- BMPs and COAs placed on the Form 2A are incorporated as BMPs and COAs on the Form 28.
