INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

On February 12, 2018, historical impacts were discovered during abandonment activities at the Sekich Farms 16-18 production facility, and excavation activities were initiated. Groundwater was encountered in the excavation at approximately 6 feet below ground surface (bgs). The COGCC has issued Spill/Release Point ID 454089 for this release.

Soil samples were collected as described in the Initial Form 27. Based on the data presented, impacted soils in the excavation area were remediated to be in full compliance with COGCC standards.

Proposed Groundwater Sampling

- ☒ Will groundwater samples be collected as part of this investigation? (Number, analyses, and locations of samples):

On September 18, 2018, four (4) temporary groundwater monitoring wells (BH01 - BH04) were installed to further assess the extent of potential remaining groundwater impacts. Quarterly groundwater sampling was initiated on September 28, 2018, and is ongoing. Groundwater samples are collected from the temporary monitoring wells on a quarterly basis and analyzed for benzene, toluene, ethylbenzene, and total xylenes (BTEX). Groundwater analytical data is presented in Table 1, and the groundwater sample locations are illustrated on Figure 1. The laboratory analytical reports are provided as Attachment A.

SOURCE REMOVAL SUMMARY

Describe how source is to be removed.

On February 12, 2018, approximately 20 cubic yards of impacted soil were excavated and transported to the Kerr-McGee Land Treatment Facility in Weld County, Colorado. Approximately 0.25 barrels of impacted groundwater were removed from the excavation area via vacuum truck and transported to the Kerr-McGee Aggregate Recycle Facility in Weld County, Colorado for treatment.

REMEDIATION SUMMARY

Describe how remediation of existing impacts to soil and groundwater is to be accomplished (i.e. summarize remedial action plan). Provide a brief narrative description including: technical justification, schedule for implementation, estimated time to attain NFA status, plus plans and specifications for the selected remedial action technology.

Laboratory data indicate that impacted soils in the excavation area have been remediated to be in full compliance with COGCC standards. Prior to backfilling, approximately 44 pounds of activated carbon were added to the groundwater within the excavation area to mitigate potential remaining hydrocarbon impacts in groundwater. Quarterly groundwater monitoring is ongoing and will be continued until concentrations remain in full compliance with COGCC standards for four consecutive quarters. Estimated time to attain NFA is TBD based on the groundwater concentrations, the extent of impacted groundwater, and the efficacy of the selected remedial technologies.

On September 18, 2018, 4 temporary groundwater monitoring wells (BH01 - BH04) were installed at the site to further assess the extent of potential remaining groundwater impacts. The 4 temporary monitoring wells will continue to be sampled on a quarterly basis and submitted for laboratory analysis of BTEX until concentrations remain in full compliance with COGCC standards for four consecutive quarters. Groundwater sample locations and a potentiometric surface contour map for the Fourth Quarter 2018 are illustrated on Figure 1. Well completion logs for the temporary monitoring wells are included as Attachment B.
