Operator Comment: After lengthy negotiations with the landowner they agreed to allow BP access to the property to install a rock rundown to slow the velocity of storm water on the northwestern corner of the well pad. BP has installed the BMP's authorized by the surface owner. BP no longer has access to this location without contacting the landowner and having them unlock the gate for BP or it's contractors. Landowner believes that the surface has been returned to them and they intend to utilize this land as an area for storage for their equipment and belongings as they see fit.

COGCC Decision: **Not Approved**

COGCC Representative: Conditions of approval on the requested final reclamation variance will likely require BP to access the location to install long term stabilization measures.

Comment: Corrective Actions have been addressed to the best of BP's ability as the well was plugged and abandoned in 2013 and the surface owner has since removed the BP lock and BP can only access when landowner will agree to unlock the gate.
