Surface Casing: 8 5/8" 24# @ 542' w/ 420 sxs

Production Casing: 4 1/2" 11.6# @ 6869.7' w/ 700 sxs cmt (TOC @ 556' - CBL).

Tubing: 2 3/8" tubing set @ 6660' (9/8/2014).

Proposed Procedure:

1. MIRU pulling unit. Pull 2 3/8" tubing.
2. RU wireline company.
3. TIH with CIBP. Set BP at 6460'. Top with 2 sxs 15.8#/gal CI G cement.
4. TIH with tubing to 1900'. RU cementing company. Mix and pump 40 sxs 15.8#/gal CI G cement down tubing (Pierre coverage from 1900'-1400'). TOOH with tubing.
5. TIH with perforation gun. Shoot 2 holes for annular squeeze at 540' @ 1 SPF or preferred.
6. TIH with tubing to 742'. RU cementing company. Mix and pump 60 sxs 15.8#/gal CI G cement down tubing. Cement should circulate to surface. TOOH with tubing.
7. Close off casing returns. Hook up cement line to cement flange and pump 160 sxs 15.8#/gal CI G cement downhole and squeeze through perforations at 540' into annular space. Cement should circulate to surface.
8. Cut surface casing 6' below ground level and weld on cap.
