Operator Comment: Section of the lease road ditch where erosion was observed will be entirely reclaimed. During negotiations with the surface owner to allow construction of our Colorado Rivers Pad south of Colorado Lakes, it was agreed that portions of this road would be re-located to the south. As such, this portion of the lease road will be entirely reclaimed and re-seeded. Construction of the new lease road is anticipated to begin the week of March 3rd.

Enerplus will complete an engineering road design of the new road to determine if check dams along the new lease road will be necessary.

COGCC Decision: Approved pending re-inspection

COGCC Representative: Approved pending re-inspection of this FIR resolution acknowledges the document was received. It is not an acknowledgement that the corrective action has been passed. A field inspection will be conducted at a future date to evaluate compliance with COGCC standards.

Field Inspection Report Doc.# 682404503 conducted on 2/11/2019 confirmed the Operator made repairs but failed to install additional BMPs. It appears the repairs have temporarily stabilized the access road until the planned Final Reclamation of the access road. Note: Appears the Operator has made repairs to the silt fence that were previously observed; however, BMP is in need of maintenance.

#### OPERATOR COMMENT AND SUBMITTAL

Comment: We are still working with the landowner to get a signed delay of interim reclamation letter for this pad. We should have this and file the request for delayed interim reclamation within the next week.
