Attachments required with a Subsequent Report are a wellbore diagram showing plugs that were set and casing remaining in the hole, the job summaries from all plugging contractors used, including wireline and cementing (third party verification) and any logs that may have been run during abandonment.

	<p>1) Provide 48 hour notice of plugging MIRU via electronic Form 42.</p> <p>2) Prior to placing the 750' plug: verify that all fluid migration (liquid or gas) has been eliminated. If evidence of fluid migration or pressure remains, contact COGCC Engineer for an update to plugging orders.</p> <p>3) After isolation has been verified, pump plug and displace. If cement is not circulated to surface, shut-in, WOC 4 hours then tag plug – must be at 500' or shallower and provide 10 sack plug at surface.</p> <p>4) Leave at least 100' of cement in the wellbore for each plug.</p> <p>5) Properly abandon on-location flowlines as per Rule 1105.
