Topsoil is in the same state as the previous inspection. Topsoil has been temporarily stabilized with equipment tracking for short-term stabilization. Equipment tracking by itself would not be considered in compliance with Rule 1002.c. Operator shall consider long-term stabilization BMPs when stabilizing all stockpiles to ensure compliance under Rule 1002.c.

Per Rule 1002, all stockpiles shall be protected from degradation due to contamination, compaction and, to the extent practicable, from wind and water erosion during drilling and production operations. Per Rule 1002, BMPs to prevent weed establishment and to maintain soil microbial activity shall be implemented.
