Comment: Slopes on the east end of the location remain predominantly bare and exposed soils. Operator appears to have implemented erosion blankets/netting along slopes. BMPs are in disrepair, no longer in proper functioning condition and requires maintenance until more permanent stabilization controls, such as perennial vegetation, has established.

Corrective Action: Install required stormwater and erosion control BMPs in accordance to Rule 1002.f and good engineering practices. Continue BMP maintenance and stormwater management until final reclamation has passed.
