Corrective Action: Perform reclamation in accordance to COGCC 1004 reclamation rules and requirements. Remove the remaining equipment and gravel from the location, perform compaction alleviation, re- contour/re-grade. Establish vegetation with total perennial, non-invasive uniform plant cover of at least eighty (80) percent of reference area levels. Ensure erosion controls are implemented to stabilize the seeded soil. Operator shall continue to monitor and manage this site until the location meets Rule 1004 standards. Operator is directed to perform corrective actions outlined on this inspection report immediately. Doing so may decrease the duration of the alleged violations and the penalties that may be assessed pursuant to Rule 523.

Operator Comment: This oil and gas location was shared by three operators - Kerr-McGee, Noble Energy Inc. and PDC. Kerr-McGee operates the pipeline and master meter shed that collected gas from at least four wells. Two wells, located on the same location as the midstream equipment were operated by PDC (Latham Res. 1 & Latham 2-32) and two other off-location wells are operated by Noble Energy Inc. (Latham 2-42 and 2-43). In June 2014, PDC abandoned the two wells on location (Latham Res. 1 & Latham 2-32). Subsequently, PDC removed all associated surface equipment, regraded and reseeded the area operated by PDC. At the time PDC was reclaiming the location, the master meter shed was actively operating one Noble well, Latham 2-42. Thus, the access road and a portion of the former drilling window was actively in use to support Midstream operation and thus final reclamation was not required.

As seen in the attached aerial photo, PDC did reclaim the area associated with PDC's oil and gas operations and could not reclaim the entire location, including access road, due to on-going midstream operations associated with another operator wells. It has been COGCC's policy, that the last operator with active oil and gas activity on a location is responsible for the reclaiming the remaining area when their operations are complete. Additionally, it is typical for Midstream operators to get Right of Way (ROW) agreements with the landowner and county building permit to set up the master meter shed.
